APPROVAL FROM SGX-ST FOR 60-DAYS EXTENSION OF TIME FOR THE RELEASE OF FULL YEAR RESULTS ANNOUNCEMENT AND EXTENSION OF TIME FOR HOLDING OF ANNUAL GENERAL MEETING FOR THE FINANCIAL YEAR ENDED 31 OCTOBER 2021

*Unless otherwise defined, all capitalized terms used in this announcement shall have the same meanings as ascribed to them in the announcement dated 29 December 2021 (the “**Previous Announcement**”).*

The board of directors (the “**Board**” or the “**Directors**”) of ecoWise Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) refers to the Applications submitted to SGX-ST for (i) a 60-day extension of time for announcing the FY2021 Results Announcement; and (ii) a 60-day extension of time for holding the FY2021 AGM.

APPROVAL OF APPLICATION FOR WAIVER

The Company had on 7 January 2022 received a letter from the SGX-ST informing the Company that it has no objection to the Applications (the “**Waivers**”), subject to: -

- (i) the Company making an immediate announcement of the Waivers granted, the reasons for seeking the Waivers, the conditions as required under Rule 106 of the Catalist Rules and if the Waivers’ conditions have been satisfied. If the Waivers’ conditions have not been met on the date of the announcement, the Company must make an update announcement when the conditions have all been met;
- (ii) the Board of Directors’ confirmation that the Waivers will not be in contravention of any laws and regulations governing the Company and its Constitution (or the equivalent in the Company’s country of incorporation);
- (iii) the Company’s confirmation that it is not aware of any other information (including but not limited to financial information) with respect to the Group that may have a material bearing on investors’ decisions which was not formally disclosed to the investors; and
- (iv) the Company announcing its FY2021 Results Announcement by 28 February 2022 and convening its FY2021 AGM by 30 April 2022.

(the “**Waiver Conditions**”).

The Waivers will not be effective if any of the Waiver Conditions have not been fulfilled.

SATISFACTION OF WAIVER CONDITIONS

The reasons for the Applications were set out in the Previous Announcement.

The Board confirms that:

- (i) the Waiver will not be in contravention of any laws and regulations governing the Company and its Constitution;
- (ii) the Company is not aware of any other information (including but not limited to financial information) with respect to the Group that may have a material bearing on investors' or shareholders' decisions which was not formally disclosed to the investors and shareholders; and
- (iii) the Company will announce the FY2021 Results Announcement by 28 February 2022 and convene the FY2021 AGM by 30 April 2022.

APPLICATION TO THE ACCOUNTING AND CORPORATE REGULATORY AUTHORITY ("ACRA")

The Company will be submitting an application to the ACRA for extension of time to comply with (i) Section 175(1)(a) of the Companies Act, Chapter 50 of Singapore (the "**Companies Act**") for a listed company to hold annual general meetings within four (4) months from the financial year end; and (ii) Section 197(1)(a) of the Companies Act for a listed company to file its annual returns within five (5) months from the financial year end. The Company will announce the outcome of the application in due course.

The shares in the Company have been suspended from trading on the Singapore Exchange Securities Trading Limited since 18 June 2021. Shareholders and potential investors of the Company are advised to read this announcement and further announcements by the Company carefully. In the event of any doubt, Shareholders should consult their stockbrokers, bank managers, solicitors, accountants or other professional advisers.
